#### 1. Welcome & Introductions

Tara Coffey, Board Member of the Genesee Valley Health Partnership Board of Directors, welcomed all attendees to the first General Membership meeting of 2024. Members and guests were invited to introduce themselves. Eight individuals present, sixteen on Zoom.

### 2. Treasurer's Report

Diane presented the Treasurer's Report: Year to Date Statement of Financial Activity and the Statement of Financial Position. The financial statements necessary to complete the IRS 990 and the Charities Bureau Registration sent to EFPR and are set to be filed by the May 15 deadline. All financial statements for both 2023 and YTD 2024 are available for review today, or, if you would like them emailed to you for review, please let Diane know. The Office of Rural Health has approved our 2024 contract at the same funding level as 2023 \$71,986. The contract with DOH for \$100,000 for enhancing suicide prevention awareness and programming has been fully executed. The United Way application for a two year 2025-2026 award is due by 4/1. Rachel Pena and TIC are again leading the initiatives which are requested to be full funding for the BASICS program.

3. Presentation: Maureen Murphy of Lifespan presented on the new Here2There transportation portal for planning purposes only. No rides can be booked through the portal at this time. This portal replaces Ride In Livingston. More counties participating: Monroe, Ontario and Livingston making coordination for rides between counties easier. Site can match a rider to their needs based on location and purpose of the trip. Available in both English and Spanish. Maureen recommends creating an account so the data that is collected can be more accurate. If you interact as a guest, each visit will be counted as a unique user, rather than one user going in multiple times for different rides. The site just went live last Friday. Phase 2 will utilize money from an innovation grant to build out booking and payment through RTS next year. Maureen can be reached at m.murphy@lifespan-roch.org with any questions or suggestions.



4. Presentation: Sarah Farash and Zoe Muhlum from Common Ground Health presented on the latest data from participants answers to their biggest health concerns. Beginning with mental health trainings with a focus on schools and the survivors support group which has been titled Step by Step which will kick off with an open house on April 16 at the Chip Holt Nature Center in Vitale Park.

### Suicide Prevention Taskforce

Lynne Mignemi, Chairperson of the Suicide Prevention Taskforce, reported on the group's activities.

**2023 summary:** 33 Events (23 Community Engagement, 10 Lock & Talk Livingston Zoom Meetings), 763 people reached, 320 firearm locks provided, 160 Deterra bags provided, 15 medication lock boxes provided, 23 events where printed resource information was provided. Seneca County signed an MOA and completed on board training with Lock & Talk in March 2024

Be Well in Livingston: Be Well in Livingston Story Map planned for implementation in 2024; Bridgette Guild will be the new chairperson for the Be Well in Livingston steering committee. Received lawn games (Kan-Jam, cornhole, and giant Jenga) one for each community and one extra, Also a spinner wheel for tabling events, will be held at DOH. Exploring further grant funding to support the community gardens.

Be Well in Lima: The community assessment survey extended till March 31 st, Bristol ID selected for worksite assessment to be discussed at Monday's meeting. Town is gearing up for their April Eclipse fun to include the first use of the yard games purchased by GVHP. Also preparing for the Crossroads Festival including the Lima Bean 5k. Christine Steerman has given some recommendations for books to purchase for the "Stress Less" component in hopes that they will be checked out at their library. Still working on recruitment to fully fill roles.

Be Well in Mt Morris: Cleanup/trellis construction on March 14, 2024;two planting events tentatively scheduled for early April and just after Memorial Day, Collaboration for Eclipse Party for Monday April 8 at Bellamy Park

Be Well in Nunda: Four new outdoor games received from GVHP for Community use...thank you!! 2/5 thru 3/4: 5 for 5 Fruit and Veggie Virtual FB Challenge: 10 participants and 6 successfully completed. Monthly Euchre Fun Night continues through April, then will be on hiatus for summer. 3/8: Be Well Community Cornhole Fun Night held at Nunda School Gym with 20 participants. 4/22-23: School/Community Earth Day Clean Up planned by grades 5-12 at school, as well as community resident participation. 7/6: Be Well 5K and Fun Run being planned during Nunda Americana Day (similar format to our 2022 5K). Planning sub-committee has started to meet. Community Gardens at Nunda and Dalton Schools: Be Well and School have met twice now to start planning 2024 garden. Raised beds at Nunda and soil garden at Dalton. Remaining 2023 Solar Ridge grant money received to purchase items needed for this year's gardens (i.e. tomato cages, jiffy pots for seedlings, 5-gal.buckets, compost bin for both buildings, etc.) Planning several CCE Nutrition Education Month classes at Dalton school for Grace Pre-K thru 4 th
