1. Welcome & Introductions

Tara Coffey, President of the Board of Directors; Genesee Valley Health Partnership, called the meeting to order at 2:31pm and welcomed all attendees. Members were invited to introduce themselves. Thirteen individuals present, ten on zoom. Tara introduced the first presentation today.

2. Presentation: Coleman Joyce and Alex Gilroy from Genentech on the topic of the Social Determinants of Health. Genentech is a pharmaceutical company but has an ecosystem work model and has many resources to assist rural areas in the specific strategies being used to reach better health outcomes.

3. Introductions and Nominations for Board seats

Amy Patterson, as a member of the nominating committee described the makeup of the Board of Directors and the goal of having eleven members which is the maximum number of directors allowed per the by-laws. The nominating committee canvassed current Board members, and most of them willing and able to serve another term are on the ballot today, with the exception of Robert Holt, who is recommending Ryan Bolter to fill his seat on the Board. Amy made a motion to approve the slate of candidates, Megan seconded, voice vote was taken to approve the slate of candidates on the Board of Director. All aye, no nay.

4. Treasurer's Report

Amy presented a Treasurer's Report in the form of a Financial Overview. The financial position of the Partnership is in good standing. There is approximately \$91,000 in the bank at this time, anticipating the payment of almost \$21,000 from our 3rd Qtr ORH claim in the coming weeks. The Charities Bureau Registration issue was rectified this month as we received a "reviewed and no further information required" notice. Andrea Mott reported out on Be Well in Livingston. Next meeting is in January.

Lima - Finished with presentation from Kim Arnold through PIVITAL on data collected from focus groups, school health index, Lima community survey, and the Community Health Assessment and Group Evaluation (CHANGE) assessment Completed the SWOT analysis at the November meeting and at the next meeting in December will begin identifying the top 3 strengths that they can act on, prioritizing the list of weaknesses to identify what they can focus on sooner rather than later, identifying which opportunities have the biggest ROI, and identifying the most pressing threats Participated in the Rotary Trunk or Treat event handing out apples and fruit bars (as well as candy) but all of the healthy options were gone first which they were pleasantly surprised to see! Tara and Bridgette will be stepping back in February, and will still provide any assistance/help as needed. The group will be facilitating the meetings and will be changing to an evening meeting time starting in February as well. The next 2 meetings will be on the 2nd Wednesday of the



month, still at 10 am. Another Penny Saver ad is in the works, similarly to the last ad, this one will be trying to gain community participation

Play in Lima brochure is almost ready for printing- finishing touches are being finished this week by a Be Well in Livingston Member and will be ready for review/approval hopefully by 11/22 Next meeting is 12/11 10am at Lima Town Hall and/or via zoom

Mt Morris – Had a meeting on 11/07 The community garden continues to be the most active part of BWMM and the harvest hut has been very successful. People have even been dropping off toys and Christmas items. Due to this, they discussed designating certain items for donation during the month (like specifically asking for donations of winter clothing items or baby items) will be checking with the MM Library to see if they are okay with moving forward with this idea. Christmas in MM will be held on Saturday, December 14 th Through the Trailway Towns initiative, grants will be available early next year for improvements to the Greenway Trail. Once the guidelines for these grants are released, they will review the application to see if they are eligible for some funds. Letchworth State Park and other surrounding communities are planning their First Day hikes for January 1 st at 10am, they will host and publicize a similar event to see if they can generate some interest for a hike in MM Next meeting is TBD

Trauma Informed Communities

Lydia Boyd, chairman of the Trauma Informed Communities committee reported.

1. Finished our solution-focused TIC speaker series
2. Huge outreach for Resiliency Month. This year we focused on advertising the Office of Mental Health’s new Credible Mind website.
 1. 1300 coffee sleeves delivered to local coffee shops in Liv Co
 2. 10,000 coasters delivered to bars and restaurants throughout Liv Co
 3. 1000 magnets delivered to organizations/local businesses
 4. 200 magnets in school colors to each school put in common areas where students can see them.
 5. Couple thousand stickers
 6. Also have billboards going up this month with positive affirmations on them.
3. Completed our School and Community TIC Resources Document- planning to put on the website and send out to schools. This document lists our trauma informed organizations, their contact information, and identifies therapists with a focus on trauma-informed care.
